

## Conditions of Entry

The following conditions apply to all patrons attending the Paw Party event at Flagstone Central Park on 19 August 2017 (event):

1. Patrons enter at their own risk and are expected to take reasonable precautions, particularly around dogs, to ensure the safety of themselves and others. The event organisers, Peet Limited and Peet Flagstone City Pty Ltd including their representatives (together the 'Event Organisers') are not liable for any loss or damage to the personal property of patrons.
2. Children under the age of 12 must be supervised at all times.
3. Dogs are allowed to attend the event subject to the terms and conditions outlined herein. No other animals are permitted at the event.
4. Patrons must not approach, pat or handle dogs at the event without permission from the respective owner or minder.
5. The Event Organisers may refuse admission and eject persons and their dogs from the event venue at their sole discretion. The Event Organisers reserve their right to refuse admission or eject dogs if they, or their patrons, do not meet the conditions set out herein, if they display signs of aggressive behaviour, biting, fighting or excessive barking, or interfere with the enjoyment of other patrons at the event.
6. Patrons who bring a dog to the event must comply with the following terms and conditions:
  - (a) each patron is permitted to bring a maximum of 2 dogs per person to the event;
  - (b) patrons must take full responsibility for their dog(s) and ensure they are supervised and under control at all times and are restrained as required by any applicable laws, rules and regulations. Dogs are not to be left unattended anywhere inside the event area;
  - (c) patrons must adhere to all signage and keep dogs within the permitted event areas and clear of dog-free zones and entertainment areas;
  - (d) patrons must immediately clean up after their dogs and dispose of their waste. Patrons must bring their own disposal bags; and
  - (e) patrons must accept full responsibility for any and all loss, damage and costs (including legal costs) incurred by the Event Organisers as a result of an injury sustained by their dog, or inflicted by their dog on any other dog or person at the event, and irrevocably agree to indemnify the Event Organisers from any claims, howsoever arising.
7. All dogs attending the event must:
  - (a) be on a leash at all times, unless within a specified dogs off leash or activity area, and be muzzled and otherwise restrained if required by any applicable laws or regulations;
  - (b) be in good physical health and not currently suffering from any contagious illness or infection, or displayed signs of illness or infection within the last 14 days;
  - (c) be well socialised and able to cope in close proximity to other dogs and humans for extended periods of time; and
  - (d) not have a history of behavioural problems or aggression that may pose a risk to other dogs or humans, or be declared a restricted, dangerous or menacing dog under the Animal Management (Cats and Dogs) Act 2008 (Qld) and regulation or under any local Council laws, rules and regulations.
8. Patrons irrevocably agree to indemnify the Event Organisers from any loss, damage and costs (including legal costs) incurred by the Event Organisers, howsoever arising whether directly or indirectly from any breach of these terms and conditions.
9. Patrons attending the event grant permission to be photographed by the official photographers. These images may be used in promotional material for the Paw Party event or the Event Organisers at any stage in the future.
