

## Flagstone Sweet Spot (Promotion)

### **Terms and Conditions**

### **Promotion Details**

- 1. Entry into this promotion is deemed acceptance of these terms and conditions.
- 2. This is a Game of Chance.
- 3. The promoter is Peet Flagstone City Pty Ltd (ACN 151 187 594) of Level 3, 167 Eagle Street, Brisbane, QLD 4000 (**Promoter**).
- 4. Entry into this Promotion is open to Queensland residents only aged 18 years or older (**Entrants**).
- 5. Entrants may only enter the Promotion once.
- 6. The Promotion commences at 2pm on Saturday 24<sup>th</sup> November 2018 and concludes at 4.45pm on 24<sup>th</sup> November 2018 (**Promotion Period**). No late entries will be accepted. The Promoter accepts no responsibility for any late, lost or misdirected entries.
- 7. Entrants who comply with the Eligibility Criteria will each receive one (1) entry in the Prize Draw for the chance to win one (1) \$250 voucher (**Prize**).

# **Eligibility Criteria**

- 8. To be eligible for the Promotion and to go in the Prize Draw, you must:
- 8.1 Be an Entrant as defined above; and
- 8.2 Complete in full, the entry form provided for this purpose by the Promotor at *Flagstone Display Village, Flagstone, QLD 4280* (**Entry Form**), within the Promotion Period. For the avoidance of doubt, the Entrant must complete all fields on the Entry Form in order for the entry to be valid.
- 8.3 deliver your completed Flagstone Passport to the Promotor at the Flagstone Sales Office located in the Display Village car park at Trailblazer Drive, Flagstone, Qld, 4280.

# (Eligibility Criteria)

- 9. Entrants who submit Entry Forms which:
- 9.1 contain content which, in the sole opinion of the Promoter is inappropriate or objectionable, including but not limited to content containing profanity or insulting, inflammatory or defamatory statements or generally intended to damage the reputation of the Promoter; or
- 9.2 are not submitted in accordance with these terms and conditions; or
- 9.3 are submitted in a manner which is misleading or deceptive, or fraudulent,



- will be disqualified and will not be eligible to win the Prize. The decision of the Promoter in this regard is final.
- 10. Each Entrant who meets the Eligibility Criteria is only permitted to complete the Entry Form once, and if they attempt to do so more than once, will only receive one (1) entry in the Prize Draw.

#### Prize Draw and other details

- 18. Entrants acknowledge and agree that:

- 18.2 a voucher may expire or become void and may not be redeemed if it expires or is defaced, stolen, damaged, altered or otherwise damaged or tampered with in any way;
- 18.3 neither the Promoter nor its related entities will be liable to reissue or reimburse the winning Entrant for any dollar value of any voucher which is so expired, defaced, stolen, damaged, altered or otherwise damaged or tampered with in any way.
