- The Service Provider shall indemnify and release Peet Flagstone in respect of any judgement, action, or liability for all loss, damage or injury to persons or property arising from the negligence of the Service Provider against any breach by the Service Provider of any third party intellectual property rights and against any act or omission by the Service Provider (or where the Service Provider is a minor, their parent or guardian) commenced by a third party against Peet Flagstone.
- Service Provider's agree that if they are successful provider for the Flagstone youthHYPE program they authorise Peet Flagstone to use, reproduce and or exhibit any images associated with the EOI for the purpose of advertising and promoting the Flagstone youthHYPE Program.
