

ARRANGING FOR THE CONNECTION OF METERED GAS TO YOUR NEW BUILD

Your clients can enjoy the convenience of metered LPG in their new home. Connection is simple if you follow the guidelines below.

For a smooth installation to occur timing is important. The inlet connection from the street to the meter location would normally occur at the same stage as other services such as electricity and telecommunication cables. Where possible, it is cost effective to share a common trench with another service.

Approved gas meter boxes can be purchased from local plumbing and electrical suppliers. Please check your local building regulations, as in some states boxes can be recessed into exterior brick work provided all gas pipes entering and exiting the box are external to the building. If painting the exterior of the house, it is advisable to install the box prior to the paint job commencing.

A contribution fee may be applicable depending on the development – please contact 133 LPG (133 574) or speak to your local Origin account manager for more information.

Arranging a connection is straightforward and is outlined below.

- 1) To organise the connection from the gas main in the street to the consumer's dwelling, please complete the Metered LPG Connection Form on the reverse of this page.
- 2) On receipt of this information, Origin will arrange for their contractor to install the service inlet and meter, which includes a trench if required. The meter will be capped in preparation for your gas fitter to make a connection.
- 3) If applicable, a tax invoice for the contribution fee will be sent to you at this point.
- 4) Once the installation of the meter and service inlet is complete your gas fitter can connect the customer's pipe work to the outlet of the meter and complete a certificate of compliance. In line with legislation, a copy of the compliance certificate must be faxed to Origin on (07) 3367 0012.
