RISK WARNING Participation at the Splash Lagoon (the Activity) is a water and inflatable recreational activity which involves inherent, incidental and significant risks, including but not limited to, collision with objects, collision with other persons, personal misjudgement and failure of equipment. The pools and obstacles of the Splash Lagoon are all inflatable items anchored in place. As such they are slippery and can be unstable. The risks in participating in the Activity may result in or materialise in harm including physical harm such as injury, disability or death. People with heart or health problems, or pre-existing injuries should not participate in the Activity.

I acknowledge that I am about to engage in a water inflatable recreational activity and I fully understand the risks involved.

TERMS AND CONDITIONS

The Participant (or Guardian for the Participant under 18 years of age) must initial each line below, confirming they have read each clause

- 1. In consideration for the participation in the Activity, the Participant agrees:
 - (a) to be bound by the contents of this document;
 - (b) that it has read and understood the Operator's Rules and Conditions of Entry (set out below); and
 - (c) that it has capacity to enter this document.
- 2. The Participant acknowledges and agrees that it hereby waives any liability for a breach of contractual, statutory or tortious duty of care and releases, indemnifies and holds harmless the Operator with respect to any claim for, but not limited to:
 - (a) negligence for breach of duty of care, failure to warn or failure to exercise reasonable care and skill;
 - (b) breach of contract for breach of any express or implied warranty, obligation, term or contractual duty of care; or
 - (c) breach of any statute, or statutory warranty (to the extent that the warranty can be excluded) or implied term,

for any injury, loss, damage, death and economic loss whatsoever suffered by the Participant or any person, whether consequential, direct or indirect, caused by or connected with the Participant's participation in the Activity.

RULES AND CONDITIONS OF ENTRY

- 1. Lifesavers are not babysitters; parental or adult supervision of children is required.
- 2. No smoking within the boundary of the Splash Lagoon area or within 100 metres of the entrance of the Splash Lagoon area.
- 3. No alcohol to be brought into or consumed within the Splash Lagoon area.
- 4. No entry to pools without an armband.
- 5. Follow operator's instructions at all times.
- 6. Maximum 150 swimmers per session.
- 7. Maximum weight on slides 90kg per person.
- 8. Yes, you can have floaties on your child.
- 9. Splash Lagoon's pools are mainly suited for ages under 13 years. All community members welcome, but should any patrons misbehave or don't follow directions from staff, they will be asked to leave the premises and no refund will be given.
- 10. Please ensure swimmer nappies are used for younger children.
- 11. No large floating devices allowed, eg surfboards, tyre tubes, aqua ducks, blow up thongs.
- 12. No hot food or drinks allowed near pools, please keep food and drinks in allocated area.
