

### Flagstone Christmas Party Promotion (Promotion)

#### **Terms and Conditions**

#### **Promotion Details**

- 1. Entry into this promotion is deemed acceptance of these terms and conditions.
- 2. This is a Game of Chance.
- 3. The promoter is Peet Flagstone City Pty Ltd (ACN 151 187 594) of Level 3, 167 Eagle Street, Brisbane, QLD 4000 (**Promoter**).
- 4. Entry into this Promotion is open to Queensland residents only aged 18 years or older (Entrants).
- 5. Entrants may only enter the Promotion once.
- 6. The Promotion commences at 4pm on Saturday 16 December 2017 and concludes at 7pm on Saturday 16 December 2017 (**Promotion Period**). No late entries will be accepted. The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.
- 7. Entrants who comply with the Eligibility Criteria will each receive one (1) entry in the Promotion prize draw for the chance to win one (1) voucher for one (1) night's accommodation (twin share) at The Star Gold Coast to the value of \$500 (**Prize**).

## **Eligibility Criteria**

- 8. To be eligible for the Promotion and to go in the Prize Draw, you must:
- 8.1 Be an Entrant as defined above; and
- 8.2 Complete in full, the form on the iPad provided for this purpose by the Promotor at *Flagstone Central Park, Jimboomba, QLD 4280* (**Entry Form**), within the Promotion Period. For the avoidance of doubt, the Entrant must complete all fields on the Entry Form in order for the entry to be valid.

# (Eligibility Criteria)

- 9. Entrants who submit Entry Forms which:
- 9.1 contain content which, in the sole opinion of the Promoter is inappropriate or objectionable, including but not limited to content containing profanity or insulting, inflammatory or defamatory statements or generally intended to damage the reputation of the Promoter; or
- 9.2 are not submitted in accordance with these terms and conditions; or
- 9.3 are submitted in a manner which is misleading or deceptive, or fraudulent,



- will be disqualified and will not be eligible to win the Prize. The decision of the Promoter in this regard is final.
- 10. Each Entrant who meets the Eligibility Criteria is only permitted to complete the Entry Form once, and if they attempt to do so more than once, will only receive one (1) entry in the Prize Draw.
- 11. It is the Entrant's responsibility to ensure that they correctly comply with the Eligibility Criteria and complete the Entry Form to enter the Prize Draw.

#### Prize Draw and other details

- 12. The Promoter will conduct a random draw to select the Prize winner at 7:45pm on Saturday 16 December 2017 at Flagstone Central Park, Jimboomba, QLD 4280 (**Prize Draw**). The Entrants must be present at the Prize Draw to be eligible for the Prize.

- 14. The first Entrant drawn in the Prize Draw who has satisfied the Eligibility Criteria and is present at the Prize Draw, will be declared the winner.
- 15. The winning Entrant will be notified in person and must be present at the Prize Draw and identify themselves to the representative of the Promoter who performs the Prize Draw within 2 (two) minutes of the Prize Draw in order to receive the Prize.

If the first Entrant drawn in the Prize Draw does not identify themselves to the representative of the Promotor who performs the Prize Draw within 2 (two) minutes of the Prize Draw, the first Entrant will forfeit the Prize. A redraw will immediately be conducted to determine the winning Entrant in accordance with terms 12 through 15 of these terms and conditions.

- 18. Entrants acknowledge and agree that:

- 18.2 a voucher may expire or become void and may not be redeemed if it expires or is defaced, stolen, damaged, altered or otherwise damaged or tampered with in any way;
- 18.3 neither the Promoter nor its related entities will be liable to reissue or reimburse the winning Entrant for any dollar value of any voucher which is so expired, defaced, stolen, damaged, altered or otherwise damaged or tampered with in any way.
