## **Terms and Conditions**

## **Promotion Details**

- Entry into this Promotion is deemed acceptance of these terms and conditions.
- 2. This is a game of chance.
- 3. The promoter is Peet Caboolture Syndicate Limited. ACN 103 038 688 of Level 3, 167 Eagle Street, Brisbane, QLD 4000 (**Promoter**).
- 4. Entry into this Promotion is only open to Queensland residents aged 18 years or older.

# **Eligibility Criteria**

- 8. To be eligible for the Promotion and to go in the Prize Draw, you must within the Promotion Period:
